Good Afternoon Board of Directors:

I am a citizen and taxpayer. MARTA has committed several Open Meetings Act violations. Recently the MARTA Board voted on a contract for acting CEO Collie Greenwood. However, this item was not on the July or August Board Meeting Agendas. The Board had expected to vote on the matter during the meeting however, it failed to place the items on the agenda

In another inequity practice, Why is it that you are giving Clayton County a designated GM to oversee Clayton County's projects and funding, while Fulton and DeKalb Counties' taxpayers who have been parties to the RTCA for more than 50 years continue to be treated and neglected and taken advantage of?

During the summer the MARTA Board voted to approve the Deputy Assistant GM/CEO Maria Anderson-Bomar for Transit to leave to go to the City of Atlanta and replace her with the Director of Transportation from the City of Atlanta Josh Rowan. I assume that there were waivers granted since Ms. Bomar did not wait a year before going to work for the City of Atlanta and had an interest in the MARTA. This action continues the practice of rotating employees, contractors, and government employees from the City of Atlanta, Fulton, and DeKalb Counties to MARTA.

This is one of the main reasons that taxpayers' interests are not being protected because instead contractors are in bed with the government employees, so the contractors and MARTA have an interest in extending the one percent sales tax and the RTCAA contract beyond the 50 years it was intended.

As you know I have a lawsuit related to one percent sales tax and the RTCAA contract. The case is on appeal before the Georgia Court of Appeals, I am seeking to enjoin illegal sales tax levy extension actions regarding the collection and spending of taxpayer funds beyond the authorized RTCAA contract expiration date consented to by voters in 1971.

All citizens have a right to expect those who practice law or hold an office of trust and who take an oath to faithfully follow the law. It is the right of all citizens to hold their government accountable within the provisions of the Constitution through a petition, and the use of the courts, and that is what I am doing.

MARTA should stop violating the law, write a new RTCAA contract and hold a new referendum. I am open and ready for a real settlement discussion, not the big bad wolf approach. I will fight with every fiber of my being to exercise my rights as a citizen and taxpayer. I will fight the good fight and get into good trouble. I will not surrender my rights as a citizen.

During the summer the MARTA Board voted to approve the Deputy Assistant GM/CEO Maria Anderson-Bomar for Transit to leave to go to the City of Atlanta and replace her with the Director of Transportation from the City of Atlanta Josh Rowan. I assume that there were waivers granted since Ms. Bomar did not wait a year before going to work for the City of Atlanta and had an interest in the MARTA. This action continues the practice of rotating employees, contractors, and government employees from the City of Atlanta, Fulton, and DeKalb Counties to MARTA.

This is one of the main reasons that taxpayers' interests are not being protected because instead contractors are in bed with the government employees, so the contractors and MARTA have an interest in extending the one percent sales tax and the RTCAA contract beyond the 50 years it was intended.

As you know I have a lawsuit related to one percent sales tax and the RTCAA contract. The case is on appeal before the Georgia Court of Appeals, I am seeking to enjoin illegal sales tax levy extension actions regarding the collection and spending of taxpayer funds beyond the authorized RTCAA contract expiration date consented to by voters in 1971.

# Resolution Authorizing the Disposal of Permanent Easements to the Georgia Department of Transportation (GDOT) in the amount of \$49,900.00 for Traffic Signal Upgrades at SR 154/Lee Street at three locations, Fulton County, Atlanta GA

WHEREAS, the Board of Directors (Board) of the Metropolitan Atlanta Rapid Transit Authority (MARTA) adopted on August 9, 1982 a policy regarding the disposition of MARTA property rights; and

WHEREAS, GDOT has requested permanent easements from MARTA in order to support traffic

signal upgrades at various locations; and

WHEREAS, the Board has determined that permanent easements on the Parcels C4186B will not interfere with rapid transit system construction, operation or maintenance; and

WHEREAS, section 8(r) of the MARTA Act of 1965 as amended permits MARTA to dispose of property to municipalities and government agencies without seeking competitive bids, provided that the Authority receives consideration at least equal in value to the disposed interest, as established by independent appraisal; and

WHEREAS, Parcels have been appraised for a total fair market value of \$49,900.00 for C4186B; and

**RESOLVED THEREFORE**, by the Board of Directors of the Metropolitan Atlanta Rapid Transit Authority that the General Manager/CEO or his delegate is hereby authorized to do all acts, perform all things, and execute on behalf of the Authority all instruments of conveyance, other instruments and agreements as necessary to effectuate the disposal of permanent easements on Parcel C4186B to the Georgia Department of Transportation upon receipt of \$49,900 equal to the appraised value of the property rights.

## RESOLUTION AUTHORIZING RENEWAL OF AUTHORITY'S NETWORK AND CYBER SECURITY LIABILITY INSURANCE COVERAGE 2022-23

WHEREAS, MARTA has privacy and network security liability (cyber) insurance coverage with limits of \$ 5 million dollars with an expiration date of September 15, 2022, and

WHEREAS, negotiations by MARSH have resulted in proposals for replacing this policy, effective September 15, 2022 for one-year, to September 15, 2023, and

WHEREAS, such privacy and network security liability (cyber) insurance coverage is available for a one-year period and includes limits of \$ 5 million dollars excess of a self-insured retention of \$ 1 million dollars at a total not to exceed cost of \$ 442,500,and

**RESOLVED THEREFORE,** that the General Manager/CEO or his designee is hereby authorized and directed to affect the placement of privacy and network security liability (cyber) insurance coverage, effective September 15, 2022 to September 15, 2023 at a total not to exceed cost of \$ 442,500.

#### RESOLUTION AUTHORIZING A MODIFICATION IN CONTRACTUAL AUTHORIZATION FOR THE MASTER SERVICES AGREEMENT, LOA L50057 WITH TALENT CONNECTIONS, LLC AND HEADWAY WORKFORCE SOLUTIONS, INC.

WHEREAS, on October 21, 2021 MARTA entered a contract with Talent Connections, LLC and Headway Workforce Solutions, Inc. under a single Letter of Agreement L50057 ("Contract") for a variety of human resource needs; and

WHEREAS, on May 26, 2022 the Contract was extended by four months and the value of the Contract was increased to \$228,500.00; and

WHEREAS, MARTA staff has determined that it is in the best interest of the Authority to further extend the term of the Contract by six months and increase the Contract value by an additional \$180,000.00 to allow Talent Connections, LLC and Headway Workforce Solutions, Inc. to continue providing services under the Contract; and

WHEREAS, the Department of Internal Audit will be requested to perform a price analysis to determine fair and reasonable pricing; and

**RESOLVED THEREFORE,** by the Board of Directors of the Metropolitan Atlanta Rapid Transit Authority that the Interim General Manager/CEO or his delegate be and hereby is authorized to extend the Contract term by six months and increase the authorization for Contract No. L50057 from \$228,500.00 to \$408,500.00.

#### Resolution Authorizing the Execution of a Lease Agreement with the Owners of 575 Morosgo Drive NE, Atlanta, GA 30324, for Short Term Relocation of Annex Employees

WHEREAS, employees are currently located in the MARTA Annex facility at 2400 Piedmont Road NE, Atlanta, GA 30324, an obsolete building in need of significant investment; and

WHEREAS, the Staff has determined that MARTA employees need to be relocated on a short term basis; and

WHEREAS, section 16(g) of the MARTA Act of 1965 as amended permits MARTA the power to acquire property, both real and personal, or rights of easement therein, or franchises necessary or convenient for the purposes of the Authority, by gifts, purchase, lease (as lessee) or contract; and

WHEREAS, lease terms are being negotiated to house employees at 575 Morosgo Drive, Atlanta, GA 30324 for a three (3) year initial term with three (3) one-year extension options for total gross rental payments equal to \$13,065,000 for the initial term; and

WHEREAS, the MARTA Board of Directors approved the FY23 Capital Project List which includes a line item for Facilities Master Plan, and it will be used for tracking expenses of this effort.

**RESOLVED THEREFORE,** by the Board of Directors of the Metropolitan Atlanta Rapid Transit Authority that the Interim General Manager/CEO or his delegate is hereby authorized to do all acts, perform all things, and execute on behalf of the Authority all instruments of conveyance, other instruments and agreements as necessary to effectuate the execution of lease documents with the Owners of 575 Morosgo Drive, Atlanta, GA 30324 on behalf of the Metropolitan Atlanta Rapid Transit Authority in the amount of \$13,065,000 gross rental payments for the initial three (3) year term.
