### **Overview**

- On Nov. 4, 2014, residents of Clayton County approved a referendum to join MARTA.
- MARTA has planned enhancements in Clayton County (e.g., improved bus service, high-capacity transit services and a new Operations & Maintenance Facility)
- MARTA and Clayton County agree that a Program Coordinator would be an asset to transit delivery in the County. The position will be employed by Clayton County, report to the County COO and the salary will be reimbursed by MARTA
- Program Coordinator, among other duties as assigned by the County, will:
  - Coordinate MARTA/Clayton projects
  - Assist with issue resolution between and among various County departments
  - Assist with Clayton County MARTA Citizen Advisory meetings
  - Attend MARTA meetings and provide County input regarding MARTA projects as needed
  - Develop a variety of reports for the County
- Term of 3 years with two (2) one year options (up to five years total)
- Compensation \$260,000 annually








### Proposed Easement Agreement - Van Buren St @ Lee St







## Significant Change per IGA with City of Atlanta

- Budget deviation of 10% from the estimate at completion of preliminary design
- Changes originate with the PMT, submitted to PGC and recommendation by PGC

Significant program changes are defined as deviations, beyond thresholds defined below,

- A change in schedule is defined as a change in the implementation sequence of one project to the detriment to another project or not consistent with the approved program sequencing plan; or
- A significant budget deviation is defined as an increase/decrease in the cost of a
  project and/or a project's contribution from the More MARTA sales tax of 10% or
  more based on the budget established after the completion of preliminary design.
- Beginning in 2025 or sooner in the event of significant financial disruptions, at least every five years or as required by the Federal Transit Administration or other relevant funding entities the program will adopt an updated phasing plan incorporating the latest budget and scheduling information to include all significant program changes to ensure the program remains aligned to the More MARTA fiscal constraints.



## Request for Modification per FY2017 Tiger Agreement

• Scope, schedule and budget changes require request of modification of agreement per Article 7, sections 7.1, 7.2 and 7.3

#### ARTICLE 7. STATEMENT OF WORK, SCHEDULE, AND BUDGET CHANGES

- 7.1 **Statement of Work Changes.** If the project's activities differ from the statement of work that is described in section 2.1 and Attachment A, then the Recipient shall request a modification of this agreement to update section 2.1 and Attachment A.
- 7.2 **Schedule Changes.** If the project's substantial completion date changes to a date that is more than three months after the substantial completion date listed in section 2.2 or a schedule change would require the period of performance to continue after the period of performance end date listed in section 2.2, then the Recipient shall request a modification

#### 7.3 Budget Changes.

(a) If any of the budget amounts that are listed in section 2.3 change from the amounts listed in that section, then the Recipient shall request a modification of this agreement to update section 2.3 and Attachment C. For other budget changes, the Recipient shall request a modification of this agreement to update Attachment C unless the USDOT has consented, in writing consistent with the Administering Operating Administration's requirements, to the change.

- 17 major items considered, \$14M potential reductions
- 5 items eliminated from project scope
- 2 items to be funded by other sources
- 3 items change of material or reduction in quantity



## **Project Site Information**

- Existing Bus routes 191, 192 193, and 800.
- In July 2020, MARTA opened a temporary transit hub with shelters, seating, passenger information, and public art.
- Breeze Vending Machines were installed at the current Justice Center facility in December 2021.
- Total Area 1.7 Acre.
- More than 64% of the population is Black or African American.
- Stakeholder Workshop held on January 21, 2022.
- The Quick Build Hub will remain open during construction.
- Site secured through Use Agreement with Clayton County.

- 2 articulated bays support future BRT
- Staging lane as a provision for future electric charging
- Service building with restrooms, customer services
- Kiss/ride for pick-up and dropoff, ridesharing
