# Resolution Authorizing the Service Modifications for the August 8, 2016 Mark-Up on Routes 3, 4, 13, 15, 51, 117, 125, 181 and 191

Board members were informed that this resolution follows the detailed discussion that was held in the May 26<sup>th</sup> Operations & Safety Committee meeting. This mark-up is cost neutral.

## **Mobility Update**

On May 21, 2016, MARTA turned over the operation of MARTA Mobility to MV Transportation. Two hundred twenty (220) MARTA employee transfers to MV. There have been zero trip denials since MV took over mobility service. MTM is the new eligibility assessment services provider.

## **New Rail Vehicle Procurement Visits**

Washington, DC (WMATA) and San Francisco (BART) have modern, updated cars in their fleet. Buying new cars is a complicated process. MARTA will go on fact-finding mission to each transit; focusing on conversations with the Board of Directors, technology, community involvement, lessons learned and procurement.
